## Letter from President and Executive Director

Dear Members and Beneficiaries of the Corporation, greetings from the Board of Managers and Staff.

It is our pleasure to report that The Corporation continues to be in fine financial health with current funds of over thirty-eight million dollars. There are currently 384 members paid in full and 177 are dues paying members for a total of 561. Based on our audit, our current assets are sufficient to cover future obligations.

In 2021 \$597,294.78 was paid to Beneficiaries under the following categories: we offered 14 death benefits in the amount of \$10,000.00 each to survivors of beloved members. Because of our sound management of assets over the years, we were able to offer Annuities totaling \$178,500.00 to 119 beneficiaries. We were also able to offer Gratuities in the amount of \$278,794.78. The requests range from medical expenses to education costs and beyond.
