Advent greetings from the board of The Corporation! I write to you in this season of hope and anticipation as we rejoice in the coming of our Lord Jesus Christ. In that spirit, I thought I would give an update on something many of you are anticipating, or certainly hoping for: an increase in the annuity for primary beneficiaries. For those of you present at the most recent Annual Meeting, you may recall our membership

voted to revise the current bylaws of The Corporation permitting the board to increase this annuity guided by a Consumer Price Index measurement for the cost of living. As some may also know, this kind of change to our bylaws is contingent on approval from the IRS.

The board, on the advice of our counsel, Mr. Lee Carpenter, engaged the services of Batoff Associates, a law firm that specializes in non-profits seeking such approval from the IRS. Our application is in the form of a request titled Private Letter Ruling (PLR). I'm happy to report the Board has approved and submitted our request (PLR) to the IRS. Now we must wait for the IRS to make its decision, and although our lawyers are confident, it's always difficult to sit with kinds of uncertainty.

In some ways, how appropriate for Advent! And I think of some of us today, living in uncertainty for our quality of life, that we will see family or give Christmas gifts this year. We join you in prayer that these very real needs be met; and we offer, through our capacity to respond to your needs, a present hope anticipated by the faithful promises of God in Christ.

May all of us, accepting the uncertainties of our lives, receive the promises of hope and the assurances of faith offered to us through the Blessed Advent and Incarnation of the Lord's Anointed One, Jesus who is the Christ, and in whose reign of peace and liberating love we are one in the Spirit.
